

# Instructions - Read Carefully

This affidavit, along with a completed and signed ATF 4473, allows Capitol Armory to ship a suppressor directly to your residence upon BATFE Form 4 approval. This affidavit only applies to Texas residents.

1. This affidavit, along with the 4473, may only be filled out after you have been notified that your Form 4 has been approved.
2. This affidavit and the 4473 must be signed within 30 days of us shipping your NFA items to you. Please mail the forms expeditiously.
3. Print out the entire 4473. Read the instructions and questions / sections carefully.

**Failure to complete the 4473 form entirely or correctly will delay the processing of your shipment and may require you to mail another signed 4473 form. By law, we cannot assist you with completing this form and most questions are addressed on pages 3-6.**

**Only complete Section B on the 4473. Make sure to sign and date Number 22 and 23 at the end of Section B.**

4. You must include a copy of your Texas identification card, drivers license or license to carry. Your state issued ID must be current and up to date. Please affix to or copy onto the below affidavit.

6. You will be notified via email when we mail your forms to the TX DPS and when your suppressor ships. Expect to receive your suppressor within 2-3 weeks of mailing your completed forms. All suppressors ship to the address on your ID via UPS ground with adult signature required. We ask that you do not contact us for a status update, but if you must, please do so via email. # Non Over the Counter Affidavit

Subject to penalties provided by law, I swear that, in the case of any firearm other than a shotgun or a rifle, I am twenty-one years or more of age, or that, in the case of a shotgun or a rifle, I am eighteen years or more of age; that I am not prohibited by the provisions of chapter 44 of title 18, United States Code, from receiving a firearm in interstate or foreign commerce; and that my receipt of this firearm will not be in violation of any statute of the State and published ordinance applicable to the locality in which I reside.
